WINTER HOME SAFETY TIPS

During the cold winter months, many people look for different ways to keep warm. Because of the hazards that go along with trying to stay warm, certain methods of precaution should be taken. In order to maintain a safe and "sound" household, make sure to follow the proceeding steps to ensure a secure home.

With the added use of heat sources to maintain a comfortable temperature in the home, there are added risks that go along with that use.

Carbon Monoxide:

- Carbon Monoxide is considered the "silent killer." It is an odorless and tasteless gas that is produced by fuel burning heating equipment such as furnaces, wood burning stoves and kerosene heaters. Make sure to install at least one carbon monoxide detector near all sleeping areas.
- Never use an oven or range to heat the home. This will produce an abnormal level of carbon monoxide around your home and could be toxic.
- Never use portable electric generators inside. They are for outdoor use only.
- Make sure your heating mechanism are installed and maintained properly to disallow for the off chance of overproducing carbon monoxide.

On top of Carbon Monoxide detectors, make sure to install properly functioning smoke detectors in the home. These will ensure added safety when dealing with additional heating sources; especially when open flames are prominent in your heating options.
